



Membership Agreement – Academy Program
August 1, 2020 to July 31, 2021

This agreement is made between the Fredericksburg Soccer Club Incorporated (hereafter “FSCI”) and the parent or guardian listed below for the benefit of the child also listed below.

MEMBERSHIP: I understand the requirements for membership as defined in the Membership Plan. I understand that the child can be a member of any individual season contingent upon payment. The membership term begins with whatever occurs last; the first payment for an individual season or the first event of an individual season. The membership term ends with the last event of a paid individual season.

BEHAVIOR: FSCI has no toleration for anyone that engages in verbal abuse, physical abuse, or outward public displays of criticism towards coaches, referees, officials, or players. If this misconduct occurs, FSCI reserves the right to ban the individual from appearing at events or terminating membership.

FINANCIAL: I agree to pay the membership dues outlined in the Membership Plan for an individual season.

REFUNDS: There are no refunds regardless of reason or circumstance including membership termination. FSCI makes financial commitments on resources based on membership commitments. In exchange for this understanding, I agree to the no refund policy and not to request a refund.

FORCE MAJEURE: FSCI shall not be considered in default of its obligations to its members if there exists events beyond its reasonable control including without limitation, acts of God, acts or omissions of governmental authorities, acts of public enemy, wars, acts or threatened acts of terrorism, blockages, riots, civil disturbances, epidemics, pandemics, floods, hurricanes, tornadoes, and any other similar events, acts, or omissions beyond the control of FSCI.

IMAGE & VIDEO CONSENT: I hereby grant permission to FSCI to photograph images, video record, or audio record my child at FSCI events. The images, video, or audio will be used as an educational tool for learning, highlighting skills, or to recognize a player for an accomplishment. The images, video, or audio may appear on the internet or in various media beyond this membership term. FSCI will not publish the child’s full name in any media unless a separate release form has been signed or the child reaches high school age. I waive any rights to royalties or other compensation arising or related to the use of the images or recordings.

PARTICIPATION CONSENT: I do hereby consent to my child’s participation in all activities. In consideration for my child’s participation in this FSCI program, I do hereby release and agree to hold harmless FSCI and all persons engaged in the program for any and all injuries received by virtue of my child’s participation in the program. Insurance for injuries that may be received while participating in the program is the responsibility of the parent or guardian. FSCI shall not be held responsible for injuries of a child or for the failure to medically insure the child participating in the program. I am aware that participation includes a risk of injury such as broken bones, concussions, torn ligaments, etc. I accept the risks of my child’s participation.
