



2020-2021 Academy Program Membership Plan

MEMBERSHIP

1. Definitions
 - a. The “soccer year” is the period between August 1, 2020 to July 31, 2021.
 - b. There are three individual seasons within the “soccer year” – Fall, Winter, Spring
 - c. A child can participate in any of the 3 individual seasons contingent upon payment.
2. The membership term is defined as follows.
 - a. The membership term begins with whatever occurs last; the first payment for an individual season or the first event of an individual season.
 - b. The membership term ends with the last event of an individual paid season.
3. Membership is granted strictly to the participating child, also known as the “player”.
4. Membership is not transferable to another child or an adult.
5. Membership is terminated upon a child leaving the program.
6. Membership can be terminated by the club due to a disciplinary issue by child or parent.
7. The child is a member of the club and not of a specific team.
8. Participation in events is contingent upon compliance with the following documents.
 - a. Academy Program Rules
9. Membership is contingent upon electronically signing these documents.
 - a. Membership Agreement
 - b. Membership Plan

BENEFITS – TRAINING & GAMES

1. Membership dues cover the full cost of supplemental insurance and the game t-shirt for a child.
2. Membership dues cover the partial cost for coaches, fields, administrative tasks, and if applicable training sessions.
3. The table below outlines the benefits of each membership level known as a package.
4. A package may not be available if enrollment is full or not offered.
5. FSCI reserves the right to vary the number of scheduled training sessions per week provided that the total number of scheduled training sessions per season are met.
6. Training sessions are either 45 minutes or 60 minutes long.

1. The calendar on our website is the only official source of events.
2. The table below lists the estimated start date and end date of each season within the “soccer year”.
3. FSCI reserves the right to adjust the start date and end date of each season provided that these dates fit within the current soccer year.

MEMBERSHIP DUES

1. The membership dues for each individual season are outlined below.
2. FSCI reserves the right to offer early bird discounts off the membership dues prior to the first event of the season.
3. Membership dues are not prorated if a player joins the season late.

POLICIES

1. If there is a cancellation or a same-day schedule modification, FSCI will notify everyone via our social media pages. It is the responsibility of the parent and player to check our social media pages prior to the event.
2. If there is a full or partial cancellation of an event, we will attempt to makeup the missed time. Makeup events can occur at any time or any day. We will make up the missed time by either adding makeup days, extending time of existing days, or holding 2 sessions on 1 day.
3. Parents need to monitor the weather forecast and arrange to have their child picked up if inclement weather causes issues during an outdoor or indoor event. Some outdoor locations do not have an available shelter. Therefore, it is important that rides are present in the event of inclement weather.
4. All players need to wear shin guards. For indoor events, players need to wear indoor soccer shoes or sneakers. Cleats are not allowed indoors.

5. Children can play on the same team as their friends if they qualify for the same age division. We encourage groups of friends to sign up together.
6. FSCI reserves the right to remove a player from an activity or the program if there is parent or player misconduct.

DISCLAIMERS

1. There are no refunds regardless of reason or circumstance.
2. Schedule is subject to change due to weather or unforeseen circumstances.
3. FSCI will make a “best effort” to provide the number of scheduled training sessions and games within the scope of the force majeure clause in the membership agreement.
4. The number of training sessions is the summation of outdoor practices, indoor practices, optional practices, video sessions, or any session pertaining to teaching the game.
5. FSCI reserves the right to combine age groups at any point during the membership term.
6. If a player misses a game or practice, FSCI will not provide another game or practice.
7. There exists a scenario where a child can be a member and not participate. It is the responsibility of the parent, guardian, and child to ensure compliance with all participation requirements to avoid this scenario.
8. The membership dues do not cover the entire cost of the program for a player. FSCI provides a limited number of free benefits not covered by membership dues that would otherwise cost an additional \$100 to \$500 such as the costs for coaches, equipment, fields, administrative work performed by non-compensated staff, etc.
9. Any early bird membership dues cannot be combined with any discount or credit.
