# 2024-2025 Select Program Rules

The Select Program is challenging, demanding, and requires a high level of commitment. Our program teaches the values of hard work, commitment, resiliency, teamwork, responsibility, and loyalty. Meritocracy determines everything. This type of environment provides the best opportunity for a player to make their high school team or be noticed by a college team.

## A. Commitment

- 1. Commitment is mandatory for all events including rescheduled events.
  - a. Commitment applies to practices, games, social events, and other FSCI events.
  - b. Commitment also applies to effort, hard work, learning, self-training, and a positive attitude.
  - c. If one cannot participate due to injury, a player must still attend an event.
- 2. Please arrive at the event by the following times.
  - a. 45 minutes before the start time of a game.
  - b. 15 minutes before the start time of a practice or other FSCI event.
- 3. The maximum number of absences for FSCI events not including games without penalty are as follows.
  - a. Fall Season 3 absences non-consecutive.
  - b. Winter Season 2 absences non-consecutive
  - c. Spring Season U14 and younger 3 absences non-consecutive.
  - d. Spring Season U15 and older 2 absences non-consecutive.
- 4. Please notify your coach of an absence.
  - a. Please provide notification weeks or months in advance.
  - b. Last second notification causes disruptions to one's teammates.
- 5. If a player exceeds the maximum absences for a season, a player must attend a makeup practice.
  - a. Parent and player must secure permission to attend a makeup practice.
  - b. Makeup practice must occur for an adjacent age group.
  - c. There is a limit of 2 makeup practices per month.
  - d. Open soccer, free play or social events do not count as makeup practice events.
- 6. A player is responsible for the following.
  - a. Self-train at home for a minimum of 30 to 60 minutes every day.
  - b. Embracing the process of improvement and struggle.

### **B. Playing Time**

- 1. Merit determines playing time.
  - a. The first component of merit is commitment, discipline, effort, and energy.
  - b. The second component of merit is productivity against the relative comparison of teammates.
- 2. Every day is a tryout for playing time.
  - a. A player earns playing time. Playing time is not given.
  - b. Playing time is not guaranteed. Playing time is not an entitlement.
  - c. Playing time is not linked to the payment of membership dues.
- 3. A playing time reduction will occur in the following situations.
  - a. Not making up a missed practice
  - b. Showing up late to events consistently
  - c. Leaving early from events consistently
  - d. Lack of effort
  - e. Discipline or sportsmanship issues.
  - f. Last second notification on absences or no notification on absences
- 4. A playing time reduction for any of the items in #3 above will result in one of the following situations.

- a. Sitting out the entire first half or entire second half of a game
- b. Sitting out a full game

# C. Player Expectations

- 1. To participate in FSCI soccer events, a player must comply with the following items.
  - a. Wear the proper uniform.
  - b. Wear shin guards.
  - c. Wear proper footwear cleats (outdoor events) or indoor shoes (indoor events)
  - d. Bring water.
  - e. Bring a soccer ball.
  - f. Bring approved gear including a soccer bag, warmup, etc.
- 2. FSCI reserves the right to remove a player from an activity, event, or the program for violations of the FSCI Code of Conduct.

# **D. Parent Expectations**

- 1. The parent or guardian agrees to abide by the FSCI Code of Conduct
- 2. FSCI reserves the right to remove a player or parent from an activity, event, or the program for any parent interference, parental instruction, or parental misconduct without a refund.
- 3. Parents must pick up their child no later than 15 minutes after the end of a practice, game, or other event.
- 4. Parents are responsible for ensuring that their child meets all requirements outlined in the Player Checklist.
- 5. If the league or club imposes a fine on a parent or player for misconduct, the parent is responsible for paying the fine.

#### E. Communication

- 1. The calendar on our website contains the schedule of events.
- 2. Our Facebook page and X page are where FSCI posts cancellations or same-day schedule changes.
- 3. The parent is responsible for monitoring the calendar and Facebook/X pages prior to attending any event.
- 4. Parents are responsible for knowing all club provided communications that includes but is not limited to club emails, parent meetings, social media postings, etc.
- 5. Parents are responsible for reading and understanding the Parent Handbook, Membership Plan, Program Rules, and Player Checklist.

#### F. Other Issues

- 1. No one may use the club logo or any of its intellectual property for merchandising, t-shirts, or other usage without the express written permission of the Executive Director.
- 2. If a player does not have the proper uniform for practice, the player can still participate if they provide a receipt showing that the uniform has been purchased.
- 3. A player cannot participate in any FSCI events if a payment has been missed. This rule applies regardless of previous payments.
- 4. A player shall not participate with a soccer team at another youth soccer club. FSCI reserves the right to remove the player from further participation when this occurs.
- 5. If required, a player will need to fill out the US Club Soccer medical release or Virginia Youth Soccer Association medical release form.
