

Membership Agreement – Select Program July 1, 2025 to June 30, 2026

This agreement is made between the Fredericksburg Soccer Club Incorporated (hereafter "FSCI") and the parent or legal guardian listed below for the benefit of the child listed below. This agreement supersedes any previous agreements. There are no other promises, conditions, understandings, or agreements, oral or written, relating to the subject matter of this agreement.

<u>MEMBERSHIP</u>: I understand the Select Program Membership Plan. The benefits of the membership term begin with the event that occurs last; the first payment or July 1, 2025. The membership term ends on June 30, 2026, unless the child withdraws or is removed from the program. The member is the child.

CONDUCT: If a parent, legal guardian, or child violates the Code of Conduct, FSCI reserves the right to terminate the child's membership. I agree with the consequences in the Code of Conduct.

<u>PAYMENT</u>: I agree to pay my child's membership dues. Payment must be made with a card under my name. I agree that there are no refunds regardless of reason or circumstance. I agree to no refunds because accepting this membership prevents another child from taking membership because of limited slots. I also agree to no refund because FSCI pays for resources for your child prior to the start of the membership term to provide benefits on the first day of the membership term.

SEVERABILITY: If any provision of this agreement is determined to be invalid, illegal, or unenforceable, it shall not affect the enforceability of any other provision of this agreement. Rather, the invalid, illegal, or unenforceable provision shall be modified to the extent necessary so that it is valid, legal, and enforceable.

<u>FORCE MAJEURE</u>: FSCI shall not be considered in default of its obligations to the member if there exist events beyond its reasonable control including without limitation, acts of God, acts or omissions of governmental authorities, acts of public enemy, wars, acts or threatened acts of terrorism, blockages, riot, civil disturbance, epidemic, pandemic, flood, hurricane, tornado, snow, inclement weather, field closure, opponent withdrawing from a game, and any other similar events, acts, or omissions beyond the control of FSCI.

<u>CONSENT TO RECORD</u>: I hereby grant permission to FSCI to photograph images, video record, or audio record my child at FSCI events. FSCI uses these recordings for skills highlights, college recruitment highlights, event highlights, recognizing an accomplishment, or as a learning tool. The image, video, or audio may appear in various media beyond this membership term. FSCI will not publish the child's full name in any media unless a separate release form has been signed or the child attended high school. I waive any rights to royalties or compensation arising or related to the use of the images or recordings.

<u>PARTICIPATION CONSENT</u>: I do hereby consent to my child's participation in all activities. I do hereby release and agree to hold harmless FSCI, and all people engaged in the program for any and all injuries received by virtue of my child's participation in the program. Insurance for injuries that may be received while participating in the program is the responsibility of the parent or guardian. FSCI shall not be held responsible for injuries of a child or for the failure to medically insure the child participating in the program. I am aware that participation includes a risk of injury such as a broken bone, concussion, etc. I accept the risks of participation.
