



2026-2027 Membership Plan Select Program

MEMBERSHIP

1. Definitions
 - a. The “soccer year” is the period between 7/1 of the current year to 6/30 of the following year.
 - b. The 2026-2027 “soccer year” is the period between 7/1/2026 and 6/30/2027.
 - c. There are three seasons within the “soccer year” named Fall, Winter, and Spring.
 - d. The membership term begins with the event that occurs last; the first payment or July 1, 2026. The membership term ends on June 30, 2027.
2. Membership is granted strictly to the participating child, also known as the “player”.
3. Membership is not transferable to another child or an adult.
4. Membership terminates when a player leaves the program.
5. FSCI can terminate membership if a player or parent violates the Code of Conduct.
6. The player is a member of FSCI and not of a specific team.
7. Within the select program, there are two membership categories
 - a. Select Premium
 - b. Select Standard
8. Membership is contingent upon electronically signing these documents.
 - a. Membership Agreement
 - b. Membership Plan
 - c. Medical Release Form
9. The child is eligible to participate when the child is in good standing with payment and compliance with the following documents.
 - a. Select Program Rules
 - b. Code of Conduct
 - c. Player Checklist

BENEFITS – TRAINING

1. Membership dues cover the cost of coaches, fields, equipment, insurance, and administrative support.
2. The table below outlines the specific number of training sessions per season and per week.
3. FSCI reserves the right to alter the number of scheduled training sessions per week provided that the total number of training sessions per season fits within the range below.
4. The number of training sessions is the summation of outdoor practices, indoor practices, optional practices, supplemental practices, classroom sessions, and video sessions.

1. Membership dues do not cover the cost of games. Game costs include league fees, referees, and tournaments.

3. The number of games is the summation of league games, tournament games, friendlies, scrimmages, and non-league games.

BENEFITS - SCHEDULE

1. The team calendar on our website is the only official source of events.
2. The table below lists the estimated start date and end date of each season within the membership term.
3. Any period not covered by a season is an offseason period where optional events occur.
4. FSCI reserves the right to adjust the start date and end date of each season provided that these dates fit within the “soccer year”.

MEMBERSHIP DUES

1. The table below outlines the membership dues for the following member categories.
 - a. Member
 - b. Returning Member 1
 - c. Returning Member 3+
2. A “returning member” is a player that registered in the 2025-2026 “soccer year”.
3. A “returning member” qualifies for the “returning member fee” as follows.
 - a. Player registers by May 2, 2026
 - b. Player paid their membership fees in full in any past “soccer year”
 - c. Player or parent did not violate the FSCI Code of Conduct in any past “soccer year”.
4. The category “Returning Member 1” is a returning member that participated in the select program, futures program, or academy program in the 2025-2026 “soccer year”.
5. The category “Returning Member 3+” is a returning member that participated in the travel program, select program, or the futures program in all three of the following consecutive “soccer years” - 2025-2026, 2024-2025, and 2023-2024.
6. When a player starts their membership after the 2026-2027 “soccer year” begins, the table below outlines the discount from the member fee that determines the prorated member dues. The table also shows the number of monthly payments for those choosing the monthly payment option. The prorated member dues apply regardless of the number of missed events.
7. The cost of the required uniform is not covered in the membership dues.
8. A family that registers 3 or more children in the Select program qualifies for a 50% discount on the third child and beyond contingent upon the following requirements.
 - a. Proof that all children are living in the same household.
 - b. The 3rd child is the child that has the lowest membership fee.

PAYMENT DISCLAIMERS

1. There are no refunds regardless of reason or circumstance.
2. If we are unable to process a payment, there is a \$20 reinstatement fee.
3. If a chargeback occurs, there is a \$50 fee.
4. If there is a missing payment, the player is not in good standing. Therefore, the player ceases participation until FSCI receives the missing payment. This applies regardless of previous payments.
5. For automated payments, the first payment is taken out immediately. Subsequent automated payments generally come out on the 1st or 15th of the month.
6. If a parent chooses the automated payments option, the parent agrees to maintain a card on file until the completion of all automated payments.
7. The card holder's name must be one of the parents that signed the membership agreement.
8. A returning player that does not make payment by the May 2 deadline forfeits their jersey number and must purchase new uniforms with a new jersey number.
9. Any prorated membership dues cannot be combined with any other discount or credit.

OTHER DISCLAIMERS

1. Schedule is subject to change due to weather or unforeseen circumstances.
2. FSCI reserves the right to implement a player rotation system where each player dresses for the minimum number of games listed per season contingent on the player abiding by the program rules.
3. Merit determines the placement of a player on a team.
4. FSCI reserves the right to combine age groups at any point during the membership term.

5. FSCI reserves the right to provide a substitute game, league, or tournament.
6. If a player misses an event, FSCI will not provide another event.
7. There exists a scenario where a child can be a member and not participate. It is the responsibility of the parent, legal guardian, and child to ensure compliance with all participation eligibility requirements to avoid this scenario.
8. There is no guarantee that the current uniform will be used in the next “soccer year”. Everyone should expect to change into new uniforms every “soccer year”.
9. The parent(s) consent to receiving communication from FSCI via email, text message, and phone.
10. Some players in the U17, U18, or U19 age groups may participate in a special college showcase event that requires an additional payment because the event is not covered in membership dues.
